INTRODUCTION

The Cusop Parish Development Plan will be a statutory 'neighbourhood development plan' under the Localism Act 2011.

Cusop Parish Council decided in May 2012 to go ahead with the production of this Plan. The area to which the Plan applies will be the same as the area of the Parish of Cusop: this was established by designation of the Parish as a 'neighbourhood area' under the Localism Act, confirmed by Herefordshire Council in September 2012.

The Parish Council established the Cusop Planning Project Group in October 2012 to manage the process of consultation and drafting of the Plan. The Group's Terms of Reference are:

"to act on behalf of the Parish Council as a volunteer steering group to organise the drafting of a Cusop Parish Development Plan and Parish Plan Update, following good practice."

The scope of a neighbourhood development plan overlaps that of a 'parish plan' which covers a wider range of community matters. Cusop adopted a Parish Plan in 2006. This project will therefore use the opportunity to update the Parish Plan at the same time. The continued need for, and scope of, a Parish Plan will depend on the consultation responses: if the all the parish's concerns can be substantially addressed through the development plan, a Parish Plan may not be needed as well. Conversely if a number of non-planning initiatives are wanted then a continuing Parish Plan may be the best vehicle for them.

ORGANISATION

<u>Cusop Parish Council</u> has statutory responsibility for initiating the Development Plan and it must approve the final draft of the Plan for submission to Herefordshire Council. In practice it will delegate responsibility for drafting of the Plan to the Project Group. The Plan will be a standing item on agendas of the Council's meetings in order to review progress and to consider any matters put to it by the Project Group or any other body or individual.

<u>Cusop Planning Project Group</u> will be responsible for all aspects of the drafting of the Plan unless otherwise determined by the Parish Council. The Group will have special responsibility for consulting the whole community of Cusop and also non-resident consultees. At the time of writing this Plan the Group members are:

The Group may appoint other people to the Group in due course. It will also encourage the involvement of other people in specific tasks and topics without their necessarily becoming standing members of the Group.

<u>Herefordshire Council</u> is responsible for checking that the draft Plan meets the legal requirements and for arranging the public examination and parish referendum. The Council's Neighbourhood Planning Team will provide extensive support as set out in the Service Level Agreement with the Parish Council. The point of contact in the Team will be the Cusop Support Officer, Samantha Banks. The Ward Member Cllr Philip Price will also be involved as appropriate.
